PORTARLINGTON GOLF CLUB'S PRIVACY POLICY

• COMPLIANCE WITH PRIVACY LEGISLATION

Portarlington Golf Club takes seriously its obligation to safeguard personal information about its Members, Staff and Customers. This policy formalises and strengthens this commitment to our Members and Customers. Portarlington Golf Club complies with the National Privacy Principles (NPPs) in the *Privacy Act* 1988.

COLLECTION OF PERSONAL INFORMATION

Personal information is generally defined as information or an opinion that can identify a person. The type of personal information that Portarlington Golf Club may collect will depend upon what dealings the Members and Customers may have with Portarlington Golf Club.

• USE AND DISCLOSURE OF PERSONAL INFORMATION

In general, our policy is that we only use or disclose personal information for the purpose which was either specified or reasonably apparent at the time we collected it. We may also use or disclose it for any other related purpose for which a Member, Staff Member or Customer would reasonably expect it to be used.

If Portarlington Golf Club wishes to use or disclose personal information in other circumstances it will obtain the Member's or Customer's consent to do so, other then in exceptional circumstances such as:

- Where Portarlington Golf Club reasonably believes it is necessary to protect any person and/or Portarlington Golf Club's rights or property; or
- The use is authorised by law or is reasonably necessary to enforce the law.

• SHARING INFORMATION WITH OTHER ORGANISATIONS

Portarlington Golf Club will not sell Member's or Customer's personal information to other companies. The only circumstances in which external organisations may be given access to Member's or Customer's personal information are when contractors and service providers are helping operate our business or provide a service to our Members or Customers. In such events, we require organisations to agree to our Privacy Policy and to strict conditions governing how this information may be used.

MARKETING

Portarlington Golf Club will only send advertising mail to Members and Customers when:

- They have indicated their consent to receive such mail; or
- Where the advertising mail is related to the purpose for which the information was collected; or
- If it would be within an individual's reasonable expectations to receive such mail.

• SECURITY OF PERSONAL INFORMATION

Portarlington Golf Club will take reasonable steps to protect personal information it collects and ensure it is accurate and up-to-date. Member's and Customer's information is held on secure servers or in storage located in controlled environments. Employees are required to maintain the confidentiality of any personal information held by the Portarlington Golf Club.

• ACCESS TO PERSONAL INFORMATION

Members and Customers are welcome to request personal information Portarlington Golf Club holds about them.

• CHANGES IN THE FUTURE

Portarlington Golf Club reserves the right to change its Privacy Policy at any time and notify its Members and Customers by posting an updated version of the policy on its website.

PORTARLINGTON GOLF CLUB LINKS TO OTHER WEBSITES

Portarlington Golf Club provides links to other websites but as these linked websites are not under its control, Portarlington Golf Club is not responsible for the conduct of companies linked to its website and we advise you to review the privacy policies of these sites before disclosing your personal information on them.

GOLF LINK

"In regards to each Member's personal information, The Australian Golf Union (AGU) requires the information for the purposes of GOLF Link. Your personal information will only be used in accordance with the GOLF Link "Activity" and to provide you with GOLF Link services. If the requested information is not provided to the AGU you may not be able to obtain GOLF Link Services including an official Australian handicap. Should you wish, you will be able to access your personal information through the AGU upon reasonable notice."

"The GOLF Link "Activity" is defined in the AGU's agreement with the Club. This essentially covers the provision of a uniform handicapping system, the development of the sport and the funding of it. By being listed on GOLF Link, Members are inviting the AGU to provide goods and services that support GOLF Link. Members not wishing to receive marketing material should advise the AGU in wiring accordingly."
